Guidance for the management of possible infections:

1. If a person is symptomatic - there are clear signs of the disease, such as persistent

cough, malaise, difficulty breathing, the person should not be admitted to the premises.

The person should be instructed to stay at home and contact by phone a local health centre

for medical teleconsultation, or report as soon as possible to the nearest infectious

diseases ward / hospital for medical consultation using one's own transport or by

notifying 999 or 112.

2. It is recommended to follow the information of the Chief Sanitary Inspector

(www.gis.gov.pl) and the Ministry of Health (www.gov.pl/web/koronawirus), as well as

the applicable laws.

3. If a student is alarmingly symptomatic, they shall be immediately removed from the

classes, isolated in a separate room or a designated place with a minimum of 2 m distance

from other persons.

4. In case the student's health condition does not require the assistance of Emergency

Medical Services (PL: PRM), they should go home by individual transport (own or

sanitary), stay there and use medical teleconsultation.

5. In case the person's condition worsens, an ambulance shall be called to transport the

person to the nearest infectious diseases ward / hospital and the situation shall be

immediately reported to the appropriate county sanitary-epidemiological station, which

will take the patient's initial epidemiological history.

6. It is obligatory to report the incident to the manager of the facility, which will allow

the staff to determine the area of the person's whereabouts, to carry out routine cleaning

in accordance with the procedures of the facility and to disinfect the high-touch surfaces

(door handles, handrails, etc.).

7. It is compulsory to establish a list of employees, visitors, students (if possible) being

at the same time in the part/parts of the facility where the person with suspected infection

was present and to recommend to comply with the guidelines of the Chief Sanitary

Inspector relating to persons who have come into contact with the infected person,

available at: www.gov.pl/web/koronawirus/ and www.gis.gov.pl.

8. Taking into account the ensuing case, it is of vital importance to follow the

recommendations of the State County Sanitary Inspectorate in determining whether

additional procedures should be implemented.
